

## ABSTRAK

Tindakan *labelling* merupakan tindakan yang umumnya terjadi di lingkungan masyarakat dan khususnya terjadi dalam lingkungan pendidikan, karena seringnya interaksi yang terjalin diantara para santri, memicu yang namanya tindakan *labelling*. Penelitian ini bertujuan untuk menganalisis munculnya tindakan *labelling* di lingkungan santri dan pengaruhnya terhadap kondisi motivasi belajar santri. Metode penelitian yang digunakan adalah pendekatan kualitatif dengan jenis penelitian deskriptif. Penelitian ini dilakukan untuk mengetahui awal mula munculnya tindakan *labelling* dan bagaimana tindakan tersebut berpengaruh terhadap motivasi belajar santri di TPQ Nurul Qur'an Wangun Daliwangun Sugio Lamongan. Teknik pengumpulan data yang digunakan yaitu, observasi, wawancara, dan dokumentasi. Analisis data yang digunakan reduksi data, penyajian data, dan penarikan kesimpulan.

Hasil dari penelitian ini menunjukkan bahwa: 1) Tindakan *labelling* muncul dikalangan santri didasari oleh beberapa faktor; pertama keadaan ekonomi, kedua tingkat kecerdasan, ketiga korban berkebutuhan khusus dan kepuasaan (2) Adanya Tindakan *labelling* terhadap santri mempengaruhi kestabilan motivasi belajar mereka, terutama bagi santri yang sering mendapatkan perlakuan *labelling*.

*The act of labeling is an action that generally occurs in the community and especially in the educational environment, because of the frequent interactions that occur between students, triggering what is called the act of labeling. This research aims to analyze the emergence of labeling in the santri environment and its influence on the conditions of santri learning motivation. The research method used is a qualitative approach with descriptive research type. This research was conducted to determine the beginning of the emergence of labeling and how this action influenced the learning motivation of students at TPQ Nurul Qur'an Wangun Daliwangun Sugio Lamongan. The data collection techniques used were observation, interviews and documentation. Data analysis used data reduction, data presentation, and drawing conclusions.*

*The results of this study show that: 1) The act of labelling appears among students based on several factors; First, the economic situation, the second level of intelligence, the third victim with special needs and satisfaction (2) The act of labelling students affects the stability of their motivation to learn, especially for students who often receive labeling treatment*
